Hist/Bio Note: The estate financial records provide a detailed account of the expenses incurred while

designing, constructing, and maintaining Vizcaya. The bulk of the records were

maintained by Paul Chalfin and his office. They were relocated with the rest of the Estate Records in 1921 with the help of W. J. Louderback, James Deering's financial manager and Miami Corporation member. The location of the collection from the 1920s to the 1950s is unknown, although it is believed to have been stored in the Superintendent's

Residence in Vizcaya Village.

Scope: This series is comprised of financial records pertaining to the planning, design,

construction, and furnishing of James Deering's Vizcaya Estate. Records include invoices,

receipts, payroll records, financial reports, checks, and bank records. The bulk of this

collection was created during the construction of Vizcaya, 1913-1921.

While dozens of companies, contractors, and suppliers are present in the records, the main creators of this collection are Paul Chalfin, Fred T. Ley & Co. Inc., and William J. Louderback. Also included are George Sykes, Phineas Paist, Fred Starbuck, and August

Koch.
